Minesto publishes prospectus in connection to the rights issue

On 2 February 2023, Minesto AB ("Minesto" or the "Company") announced that the board of directors had resolved on a rights issue of up to approximately SEK 153 million (the "Rights Issue"), conditional on the approval of an extraordinary general meeting. On 20 February 2023, the extraordinary general meeting approved the Rights Issue, which the Company announced the same day. Today, Minesto announces that the prospectus relating to the Rights Issue has been approved by the Swedish Financial Supervisory Authority and has been made available on Minesto's webpage, www.minesto.com/investors/rights-issue-2023, together with all other information related to the Rights Issue. The prospectus will also be made available on Pareto Securities' webpage, www.paretosec.com, on Skandinaviska Enskilda Banken AB:s webpage, www.sebgroup.com/prospectuses, and at the Swedish Financial Supervisory Authority's webpage, www.fi.se.
